## **RESOLUTION NO 18-06**

A RESOLUTION OF THE CITY OF COOS BAY, COOS COUNTY, OREGON, CALLING A MEASURE ELECTION TO SUBMIT TO THE ELECTORS OF THE CITY THE QUESTION OF AMENDING THE CITY'S CHARTER.

WHEREAS, the City Council of the City of Coos Bay, Coos County, Oregon (the "City"), has determined that a need exists to amend the City's Charter in order to adjust requirements for the frequency of Council meetings, to remove unnecessary provisions, to remove provisions which have been ruled unconstitutional, and to modify the process for the issuance of revenue bonds;

WHEREAS, a true and correct copy of the proposed amended City Charter is attached hereto as Exhibit A.

BE IT RESOLVED by the City Council of the City of Coos Bay, Coos County, Oregon, that:

- A. A measure election is hereby called for the purpose of submitting to the electors of the City the question of amending the City's Charter in order to adjust requirements for the frequency of Council meetings, to remove unnecessary provisions, to remove provisions which have been ruled unconstitutional, and to modify the process for the issuance of revenue bonds.
  - B. The measure election hereby called shall be held on the 15th day of May 2018.
- C. The City authorizes the City Manager, Finance Director, or the designee of either of those officials (each an "Authorized Representative") to act on behalf of the City and to take such further action as is necessary to carry out the intent and purposes herein in compliance with the applicable provisions of law.
- D. Pursuant to ORS 250.275(5) and 250.296 the City Elections official shall publish in the next available edition of The World, or in some other newspaper of general distribution within the City, a notice of receipt of the ballot title including notice that a dissatisfied registered voter may file a petition with the Circuit Court for review of the ballot title not later than the seventh business day after the ballot title is filed in substantially the form of Exhibit B.
- E. Pursuant to ORS 254.095 the City Elections official will deliver a Notice of City Measure Election in substantially the form of Exhibit B to the Coos County Elections Office.
- F. This resolution shall take effect immediately upon its adoption by the City Council.

The foregoing resolution was duly adopted by the City Council of the City of Coos Bay, Coos County, Oregon, this 20<sup>th</sup> day of February 2018.
